The Organization received a \$700,200 loan from City of Los Angeles for the development of 17-unit apartment building in the City of Los Angeles. This loan was then transferred to Hope-West Apartment, a limited partnership that provides housing to very low income families. Hope-Net is the general partner and recognizes 'Pass Thru' income and expense on this loan at annual interest rate of 6.0%.
